Please be aware when sending lunches etc. our camp programs are all peanut/nut free.

The following is a list of things that your child will need to bring each day:

- ✂ A bag lunch (including something to drink and water bottle) and snacks.
- ✂ Swimsuit and towel
- ✂ A hat
- ✂ Sunscreen and insect repellent

We spend a lot of time outdoors – rain or shine!! Please send appropriate clothing for your child.

Please do not send any sharp utensils with your child, such as jack knives - for reasons of safety.

Remember your child will be responsible for his/her own belongings. Please make sure all clothes, etc. are labeled. A small backpack is recommended for carrying these things (paper and plastic bags tend to tear and items get lost)

There is a store at Pike Lake and the children may be given an opportunity once a day to buy treats if they desire, so, you may want to include some money. Please allow no more than \$2.00 per day.
